SECTION 4: First aid measures

4.1 Description of first-aid measures

General advice

Acute pulmonary edema may develop within 24 hours and reaches a maximum by three days. The first chronic effect of exposure to cadmium is generally kidney damage, manifested by excretion of excessive protein in the urine, followed by anemia, teeth discoloration and loss of smell. Cadmium also is believed to cause pulmonary emphysema and bone disease.
